

All About Math Sweepstakes Official Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING. THE SWEEPSTAKES (DEFINED BELOW) IS INTENDED FOR THE UNITED STATES ONLY AND WILL BE GOVERNED BY U.S. LAW. DO NOT ENTER IF YOU ARE NOT ELIGIBLE AND LOCATED IN THE UNITED STATES AT THE TIME OF ENTRY. VOID IN PUERTO RICO AND WHERE PROHIBITED. 1. **Sponsor:** The All About Math Sweepstakes is sponsored by All About Learning Press, LLC with an address of 615 Commerce Loop Eagle River, WI 54521 ("Sponsor"). The Sweepstakes is in no way sponsored, endorsed, administered by, or associated with Facebook, X, Instagram, Snapchat, YouTube, Reddit, Pinterest, LinkedIn or any other social networks that are used to share the Sweepstakes. You understand that you are providing your information to the Sponsor and not to Facebook, X, Instagram, Snapchat, YouTube, Reddit, Pinterest, LinkedIn or any other social media networks.
2. **Eligibility:** The All About Math Sweepstakes (the "Sweepstakes") is open to residents of the United States, except where void, who are eighteen (18) years of age or older at the time of entry. Employees, independent contractors, interns, officers, directors, and agents of Sponsor, their respective affiliates, subsidiaries, advertising and promotion agencies, suppliers and their immediate family members and/or those living in the same household of each are not eligible to participate in the Sweepstakes.
3. **Agreement to Rules:** By entering the Sweepstakes, the entrant ("you") agrees to comply with and abide by these Official Rules and the decisions of the Sponsor, and you represent and warrant that you meet the eligibility requirements. In addition, you agree to accept the Sponsor's decisions as final and binding as it relates to the Sweepstakes. 4. **Entry Period:** The Sweepstakes begins at on July 28, 2026 at 12:00am Central Time zone and ends on August 9 at 11:59pm Central Time zone (the "Entry Period"). Entries submitted before or after the Entry Period will not be eligible.
5. **How to Enter:** The Sweepstakes must be entered by submitting an entry using the online form provided at <https://gleam.io/kGt11/all-about-math-level-of-choice> and passing any verification requirements (such as email or fraud score) set by the Sponsor. The entry must fulfil all requirements of the Sweepstakes, as specified, to be eligible to win. Entries that are incomplete or do not adhere to the rules or specifications of the Sweepstakes may be

disqualified at the sole discretion of the Sponsor. You must provide all of the information requested in the web form, otherwise your entry will be ineligible. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. **Limit: One (1) entry per person/email address.** If you use fraudulent methods or otherwise attempt to circumvent the rules of the Sweepstakes, your entry may be disqualified at the sole discretion of the Sponsor.

6. Prizes: Sponsor will award a total of five (5) prizes. One (1) prize to each of the Winners consisting of the Winner's choice of one (1) All About Math Level of the Winner's choice, plus two (2) backpacks from 1000 Hours Outside, and two (2) lunch boxes from 1000 Hours Outside (the "Prize"). Approximate retail value of the Prize is two hundred and twenty (\$220) dollars. Approximate retail value of actual Prize may vary. Any difference between stated value and actual value will not be awarded. No cash or other prize substitution shall be permitted except for at the Sponsor's discretion. The Prize is non-transferable. Substitution of the Prize or transfer/assignment of the Prize to others or request for the cash equivalent of the prize by the Winner is not permitted. Any and all Prize related expenses, including without limitation any and all federal, state, and/or local taxes shall be the sole responsibility of the Winner.

7. Odds of Winning: The odds of winning depend on the number of eligible entries received.

8. Winner Selection and Notification: The potential Prize winner ("Winner") will be selected by Sponsor randomly out of all the eligible entries received during the Entry Period on or around the day following the end of the Entry Period (the "Draw Date"). The Winner will be notified within seven (7) days of the Draw Date. The Sponsor shall have no liability for a potential Winner's failure to receive notices due to spam, junk e-mail or other security settings or for a potential Winner's provision of incorrect or otherwise non-functioning contact information. If the potential Winner cannot be contacted, is ineligible, fails to claim the Prize within seven (7) days from the time award notification was sent, or fails to timely return a completed and executed declaration and release as required, the Prize may be forfeited and an alternate Winner may be randomly selected from all eligible entries. Receipt of the Prize by the Winner is conditioned upon compliance with any and all federal, state, and local laws and regulations. likeness, image, statements about the Sweepstakes, and biographical information for news, publicity, information, trade, advertising, public relations, and promotional purposes without any further compensation to you or notice, review, or consent by you. By entering this Sweepstakes, you represent and warrant that your entry is original to you and does not infringe or violate any third party's intellectual property rights or rights of privacy or publicity. If your entry infringes upon the intellectual property, privacy or publicity right of another, you will be disqualified at the sole discretion of the Sponsor.

11. Terms and Conditions: The Sponsor reserves the right, in its sole discretion, to cancel, terminate, modify or suspend the Sweepstakes for any reasoning, including if a virus, bug, non-authorized human intervention, fraud, or other cause beyond the Sponsor's control corrupts or affects the administration, security, fairness, or proper conduct of the Sweepstakes. In such cases, the Sponsor may randomly select a winner(s) from eligible entries received before and/or after the action taken by the Sponsor if appropriate. The Sponsor reserves the right at its sole discretion to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Sweepstakes or website or violates these Official Rules. The Sponsor has the right, in its sole discretion, to maintain the integrity of the Sweepstakes, to void entries for any reason, including, but not limited to: multiple entries from the same user from different IP addresses; multiple entries from the same computer in excess of that allowed by Sweepstakes rules; or the use of bots, macros, scripts, or other technical means for entering. Any attempt by an entrant to deliberately damage any website or undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil laws. Should such an attempt be made, the Sponsor reserves the right to seek damages to the fullest extent permitted by law.

Limitation of Liability: By entering the Sweepstakes you agree to release and hold harmless All About Learning Press and its subsidiaries, affiliates, advertising and promotion agencies, partners, representatives, agents, successors, assigns, employees, officers and directors from any liability, illness, injury, death, loss, litigation, claim or damage that may occur, directly or indirectly, whether caused by negligence or not, from (i) entrant's access to and use of sponsor's websites or downloading of any material from said websites; (ii) such entrant's participation in the Sweepstakes and/or acceptance, possession, use, or misuse of any Prize or any portion thereof; (iii) unauthorized human intervention in any part of the Sweepstakes; (iv) electronic or human error in the administration of the Sweepstakes or the processing of entries; (v) technical errors of any kind, including but not limited to the malfunction of any computer, cable, network, hardware, or software, or other mechanical equipment or Internet service; (vi) printing errors; or (vii) lost, late, postage due, misdirected,
